Pursuant to the Law on Securities dated November 26, 2019 and the Law amending and supplementing a number of articles of the Law on Accounting, the Law on Independent Audit, the Law on State Budget, the Law on Management and Use of Public Assets, the Law on Tax Administration, the Law on Personal Income Tax, the Law on National Reserves, and the Law on Handling of Administrative Violations in 2024;

Pursuant to Decree No. 155/2020/ND-CP dated December 31, 2020 and Decree No. 25/2025/ND-CP dated February 11, 2025 amending and supplementing a number of articles of Decree No. 155/2020/ND-CP of the Government detailing the implementation of several articles of the Law on Securities;

Pursuant to Decision No. 02/QĐ-HĐTV dated June 30, 2021 of the Members' Council of Vietnam Exchange on the establishment of the Ho Chi Minh City Stock Exchange;

Pursuant to Decision No. 07/QĐ-HĐTV dated July 09, 2021 of the Members' Council of Vietnam Exchange promulgating the Charter of Organization and Operation of the Ho Chi Minh City Stock Exchange;

*Pursuant to Decision No. 22/QĐ-HĐTV dated March 16, 2026 of the Members' Council of Vietnam Exchange on promulgation of the Listing and Trading Regulations;

At the proposal of the Director of the Listing Management Department;

DECIDES:

Article 1. To approve **Thanh Thanh Cong – Bien Hoa Joint Stock Company** to change its listing registration with the following details:
